





Unrestricted Balance





Restricted/Reserved Balance (Excluding Capital Related)





Operating Capital Fund Balance





Long-Term Facilities Maintenance Fund Balance





Food Service Fund Balance





Community Service Fund Balance



Debt Service Fund Balance





District Enrollment ADM's (5 Year Trend)







General Fund Revenue




ISD No. 77 Mankato







